<u>Methodology</u>

- Done by the spatial planning department of the regional Council of Bourgogne-Franche-Comté. With the help of several departments: environment, economy, agriculture and wood, prospective and research and training.
- 25 stakeholders involved by interviews to identify the challenges they face. Status: public and private actors.

<u>Main conclusions</u> neetings with the regional council departments concerned.

- A regional strategy dedicated to circular economy: the regional circular economy road map + The Regional Plan for Prevention and Waste Management, including a "circular economy" action plan ;
- Many regional council levers exist in order to globally serve the circular economy:
 - The regional plan for planning, sustainable development and equality of territories;
 - The Regional Plan for Agricultural Development.
- Regional policies and instruments for research and higher education :
 - regional scheme for higher education, research and innovation
 - Regional Innovation Strategy towards Intelligent Specialization
 - Industrial Research Training Agreements

POPSU : Food democracy as an issue of territorial





Type of players involved: Tournus Municipality other Municipalities, population, university of Bourgogne-Franche-Comté « Living Lab ».

Role of **local governments:** Request + Beneficiary

Role of regional authority: No role played.

Policy feedback: Not especially related to a regional policy. But it inspires the way to answer to agriculture development, local democraty, sustainable food system...

Creation of a **"large kitchen"** to meet the needs of the rural environment where agricultural and food structures are small and the existing "transformation" or "central kitchens" workshops are few.

The ambition is to build a common workplace for farmers, food craftsmen, municipalities that make meals for children.

It is a way **to fight against food waste** by transforming the fruits and vegetables currently discarded by supermarkets, because they are worn out. This project is carried out in close consultation with the community of municipalities of Cluny, which carries real estate investments.

The aim is to demonstrate that the concept is **suitable for rural areas**, which do not have a great need for food processing on each type of actor. It also aims to focus on the territorial character of this type of project, which goes beyond the logic of "sector", and purely agricultural logic.

Together, on the same territory, these actors, farmers, restaurateurs, butchers, communities, food aid actors, have an interest in sharing a common tool, it costs less in investment (avoiding the multiplication of individual laboratories), and the economic model makes it possible to achieve profitability (thanks to the accumulation of several types of services and also to a sharing of charges and operating costs).

Role of regional authority: Managing authority for FEADER + financial support : BFC Region policy instrument on "agriculture".

Policy feedback: related to a regional policy on agriculture development. It helped to answer to a specific need. Inspiring experience that will improve the way to face the challenge.

The French law in 2015 entrusted to the regions the establishment of the Regional Waste Prevention and Management Plan and a Circular Economy Action Plan voted by the regional assembly in November 2019. The Region wished to strengthen its commitment by adopting in June 2020 a Regional Circular Economy Roadmap (FREC).

To support this movement, the Region decided to support public and private initiatives by setting up a <u>regional Call</u> <u>for Circular Economy projects</u>. Launched in **2018** in partnership with the Ecological Transition Agency, it was named in **2020** <u>« Circular Economy</u> <u>Project Accelerator »</u>.

This practise named **Circular Economy project accelerator** is interesting for other regions to learn from because creating and organizing one or several call for proposal every year allows the local stakeholders to express their need.

It makes possible the adapted answer and the development of innovative way to act **fostering circular economy**.

Policy feedback:This call for proposal is entirely related to the regional circular economy roadmap that leads the strategy planned between the regional council of Bourgogne-Franche-Comté and the Ecological Transition Agency.

A well known and relevant coordination between the 2 of them is necessary to identify the needs, to communicate on the "Accelerator" to the project leaders and to bring adapted answers to serve circular economy through the monitoring of the regional roadmap.



France Active Bourgogne-Franche-Comté supports and finances committed **entrepreneurs** and **solidarity** initiatives serving **people**, **employment** and **local development**.

The Generator **detects** and **stimulates** activities with potential within the territories it supports. Among them several **circular economy projects**.

Its methodology is based on 3 steps :

1.From needs to the idea

- Listening to the expectations of the community
- Characterization of unmet needs
- Identification of local resources
- Connecting the actors involved
- Stimulation of the production of ideas
- Choice of the territorial business project

2. From idea to project

- Conduct of an opportunity study on the identified project
- Mobilization of the necessary partners
- Identification of the project leader
- Definition of the economic model

3. From the project to the creation of an activity

- Organization of the activity
- Constitution of a partnership ecosystem
- Possible mobilization of financing tools
- Support for the project leader
